***MSHA Part 48 requires 10 Hours MSHA training and 8 Hours First Aid CPR within 60 days prior of the MSHA training (certificates will not be given until proof of 1st Aid course is verified)**

Refresher: Required Annual update, First Aid/CPR & AED needs to be current.

New Miner: For individuals that either have not been certified or have gone beyond two years since last refresher, it is mandatory to have taken First Aid/CPR & AED within 60 days prior to MSHA class.
